



## 2018 MEMBERSHIP PRIVILEGES

### **FULL MEMBERSHIP - \$40,000\***

**2018 Dues \$9,750.00**

Full Members are entitled to use the golf, tennis, swimming, wellness and dining facilities of the Club, as well as participate in all social events at the Club. Full Members have a 7-day sign-up privilege to reserve golf tee times and tennis courts. Full Members shall not pay green or court fees for use of the golf & tennis facilities, but shall pay cart fees. Full Golf Members will receive two complimentary lockers and complimentary bag storage for two bags. Full Golf Members will receive discounted greens fees for immediate family members.

### **SPORTS MEMBERSHIP - \$10,000\***

**2018 Dues \$5,850.00**

Sports Members are entitled to use the golf, tennis, swimming, wellness and dining facilities of the Club, as well as participate in all social events at the Club. Sports Members will have limited access to play golf upon payment of green fees & cart fees. Sports Members shall have a 3-day sign-up privilege to reserve golf tee times. However, from January 1 to April 30, Sports Members may only play after 10:00am & may not play golf on days so designated by the Club. Sports Members may also play golf on a space available basis on the day of play. From January 1 to April 30, Sports Members may only use the driving range on days they are playing golf, but they can purchase a range pass to have unlimited access during that time. Sports Members have unlimited use of the chipping & putting areas year-round. Sports Members shall have a 7-day sign-up privilege to reserve tennis courts & shall not pay court fees. Sports Members may participate in the Men's or Women's Golf Associations at the discretion of each Association.

### **LIFESTYLE MEMBERSHIP - \$4,000\***

**2018 Dues \$4,700.00**

Lifestyle Members are entitled to use the golf, tennis, swimming, wellness and dining facilities of the Club, as well as participate in all social events at the Club. Lifestyle Members will have limited access to play golf upon payment of green fees & cart fees. Lifestyle Members shall have a one-day sign-up privilege to reserve golf tee times. However, from November 1 to April 30, Lifestyle Members may only play once a month (no carry over) after 12:00 noon and may not play golf on days so designated by the Club. From January 1 to April 30, Lifestyle Members may only use the driving range on days they are playing golf, but they can purchase a range pass to have unlimited access during that time. Lifestyle Members have unlimited use of the chipping & putting areas year-round. Lifestyle Members shall have a 7-day sign-up privilege to reserve tennis courts & shall not pay court fees. Lifestyle Members may **NOT** participate in the Men's or Women's Golf Associations.

### **SOCIAL MEMBERSHIP - \$3,500\***

**2018 Dues \$3,450.00**

Social members shall be entitled to use the tennis, swimming, wellness and dining facilities of the Club, as well as participate in all social events at the Club. Social Members shall have limited access to play tennis upon payment of court fees and have a 3-day sign-up privilege to reserve tennis courts. From November 1 to April 30, Social Members may only play tennis after 12pm (Sunday open play at the discretion of the Pro). Social Members may not participate in Team Tennis, Round Robins or AM Special Events. Social Members shall not be permitted to use any of the golf facilities.

### **YOUNG PROFESSIONAL MEMBERSHIPS (49 YEARS OLD AND UNDER)**

The Young Professional Membership is for individuals 49 years old and under. Young Professional Memberships are available for all four membership types and are entitled to use all the same privileges as described above. These memberships allow the Young Professional to defer the initiation payment and pay reduced dues until the age 49. Young Professional Members receive a 50% discount on all Initiation Fees\* and receive a 30% discount on annual dues. Initiation fee payment schedule to be determined by age. By the age of 49, all initiation payments must be paid in full. Young Professional Member will start paying full dues the calendar year after 49th birthday.
